

## **RINGING IN HOPE RUNNING GEAR SWEEPSTAKES OFFICIAL RULES**

### **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The Ringing In Hope Running Gear Sweepstakes (the "Sweepstakes") starts on October 10, 2020 at 12:00p.m. Eastern Time ("ET") and ends on December 20, 2020 at 11:59 p.m. ET ("Sweepstakes Period"). The Sweepstakes will award one (1) Grand Prize, a Dick's Sporting Goods Gift Card valued at \$130.00.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia.
